**LEAGUE NOTES**

1. The **Official Rosters are due in the Park & Recreation Office, completely filled out, on or before 4:30 p.m. on May 19, 2016.** A late roster **will** result in at least one automatic forfeit, and no further games being played until the roster is in; the opposing team receives a win by forfeit.
2. Rain-Outs: If we can make a decision to cancel ball games prior to 4:00 p.m., we will place announcements on our local radio stations, the Park & Recreation Cancellation Line (507-457-8220) and website. After 4:00 p.m., all cancellations will become the umpire's decision. **When in doubt . . . show up!**
3. Rosters: You may **add to or delete from your roster through June 17, 2016.** Roster changes will not be permitted after that date. All players must be at least 16 years old by December 31<sup>st</sup> of the current year.
4. NOTE: The second team on the schedule will be the home team and will keep the official book. Local Home Run limit is TWO (2) per game for this league.
5. All teams are Class E with the NSF-MSF. **The Class E State-East Tournament has been set for August 13-14 in Stacey, Doyle Fields.**
6. At the conclusion of the regular season, all teams will be entered into a single elimination playoff. The league record will determine the seeding. The league winner and the playoff winner will receive trophies.
